As a Court of General Sessions, convened on November 15, 2019 the Grand Jurors of CALHOUN County present upon their oath:

COMMON LAW MISCONDUCT IN OFFICE

That from on or about May 2003 to on or about February 2019, in Calhoun County Defendant Heath Hill while serving as Chairman of the Board of Trustees of the Tri-County Electric Cooperative willfully and dishonestly failed to properly and faithfully discharge the duties of his public office imposed upon him by law, to wit: by using the office of Trustee to obtain personal benefit to himself and Defendant's family members by among other things causing Tri-County Electric Cooperative employees perform work upon property owned and controlled by Defendant and Defendant's family members at little or no cost to Defendant and his family members but which cost the Tri-County Electric Cooperative more than \$300,000; and/or obtaining electrical light service upon Defendant's property for more than fifteen (15) years at a cost of more than \$23,000 without paying the Tri-County Electric Cooperative anything for the service; and/or obtaining a cash payment in excess of \$80,000 from the proceeds of an annuity purchased by Tri-County Electric Cooperative funds and/or otherwise obtaining money and benefits to which Defendant was not entitled to receive. The Defendant did commit acts or omissions in breach of his duty of good faith and accountability to the public. All against the peace and dignity of the State and in violation of the common law of South Carolina.
