My application does not guarantee that I can have a charge(s) removed from my criminal record. Only a thorough review of my criminal record will reveal if I am eligible. I understand that the expungement process may take up to twelve (12) weeks. I understand that the administrative fee of \$250.00 that is required for all charges eligible to be expunged, is non-refundable. I understand that the Solicitor's Office is not required to consent to expungement of any charges. I understand that the Solicitor's Office is not responsible for any internet or third-party companies that have obtained my criminal information in which an expungement has been granted. I understand that if I am applying for an expungement due to the successful completion of Pretrial Intervention (PTI), and I had other charges from the same incident that were dismissed, I must apply separately for those charges to be expunged. The PTI Director will only generate an expungement order for the charges that were referred to the PTI program. I understand that, if my application is accepted by the court, I will receive a certified copy of my expungement order by mail and the Solicitor's Office will be responsible for mailing all other copies to the appropriate agencies.
